



## Scholarship Application

**Oxford Federal Credit Union** established its scholarship program to applaud the accomplishments of our student members and to support their continued education and training beyond high school.

Each spring, we award one scholarship to a student graduating from: **Buckfield, Dirigo, Mountain Valley, Oxford Hills** and **Telstar** High Schools.

## AWARD

### **OFCU Scholarship Award for \$1,000:**

- Recipients are limited to one scholarship award.
- Scholarship winners will be notified by their school's Scholarship Committee in June 2023.
- Awards will be presented at the winner's school scholarship or award ceremony.
- Money will be paid directly to the student at the beginning of the second semester of their first year, after providing proof of attendance at the college, university or technical school in which the student is enrolled.

## ELIGIBILITY

- Applicant must be a member of Oxford Federal Credit Union.\*
- Applicant must be a graduating senior at one of the eligible high schools listed above.
- Applicant must be accepted as an incoming freshman to a two-year community college, four-year college or university or technical school.
- Student must begin further education within one year of award.

## REQUIREMENTS

- Completed application and essay due no later than Friday, April 14, 2023.
- Applications may be delivered in person, emailed to **marketing@ofcu.org** or mailed to: **Scholarship Committee, Oxford Federal Credit Union, 225 River Road, Mexico, ME, 04257** for verification of Membership.
- Copy of letter of acceptance from the school of choice.
- Submission of a photo to be shared on our website if applicant is selected as a recipient.

## SELECTION

Upon receipt of your application, OFCU will send a confirmation letter.

Applications will be sent collectively to the Scholarship Committee of each high school after the application deadline, for judging of entries and selection of the scholarship recipients. *Oxford Federal Credit Union does not select the recipients.*

**Judging** is based on:

- Information gathered through the application
- Motivation to continue education
- Achievements (honors, awards), extracurricular activities, work or volunteer experience
- Written essay
  - Judged on content, creativity and clarity.
  - Spelling, grammatical or typographical errors may disqualify your entry.

*Transcripts are not required for this scholarship application.*

*Oxford Federal Credit Union (OFCU) reserves the right to discontinue this scholarship program at any time without notice. OFCU reserves the right to not award scholarships should there be no qualified applicants.*

*\*If the student is not a current member of OFCU, they may join the credit union by opening a share account with a minimum balance of \$5 prior to applying.*
